- 1. This convocation is of the view that The University Council should, in accordance with established procedures and precedents, confirm the recommendation made by the Search Committee for the appointment of Pro-Vice-Chancellor (Academic Staffing and Resources) within 30 days from today and failing that, should provide written reasons and justification for their delay and their decision to the Convocation and members of the public.
- 2. This convocation is of the view that The University of Hong Kong Ordinance and all consequential provisions including the University rules and regulations should be amended such that the Chief Executive shall not be the Chancellor and chief officer of the University.
- 3. This convocation is of the view that in the alternative to 2, the University of Hong Kong Ordinance and all consequential provisions including the University rules and regulations should be amended such that the role of the Chief Executive as the Chancellor of the University shall only be ceremonial.
- 4. The Convocation shall set up a working party for the implementation of resolutions 2 and/or 3 above.
